The Law Foundation of Newfoundland and Labrador over the twenty-five year period from 1980 to the Special Meeting on November 30, 2005 approved funding on a year by year basis to over fifty separate recipients, with several of these receiving a number of grants for different projects, totalling \$10,581,026. for the following objects:

a) legal education & legal research	\$ 1,681,388.
b) law reform	126,809.
c) legal aid	5,403,027.

The Law Foundation in 2005 had revenues of \$501,074. (4.39% annual composite prime - acp), an increase of \$141,699. from 2004 revenues of \$359,375. (4.005% acp)

Revenues: 2000, \$846,208. (7.23% acp); 2001, \$679,943. (6.01% acp); 2002, \$242,859. (4.19% acp); 2003 \$406,890. (4.69% acp).

The Foundation's equity position at December 31, 2005, its fiscal year end, comprised the Reserve Account of \$470,416. (Reserve Account \$530,780., December 31, 2004 with nil Undistributed Revenue).

Undistributed Revenue: December 31, 2005, nil; 2004, nil; 2003, nil; 2002, nil; 2001, \$132,549. (in 2001 the Board of Governors transferred \$50,000. of the year 2000 excess of revenue over expenses to the Law School Scholarships Trust Fund, increasing the Scholarships reserve to \$200,000.); 2000, \$185,351.

The Foundation maintains a separate Law School Scholarships Trust Fund. The Law School Scholarships Selection Committee annually awards entrance scholarships valued at \$5,000. each. With respect to the Reserve Account of \$470,416., it is the policy of the Foundation to maintain a deposit of \$243,748. for grants stabilization in the event of revenue reduction, \$26,668. for legal education, research and law reform (\$42,368., December 31, 2004, with \$15,700. reduction to \$26,668. listed under grants approved in 2005 Annual Report), and \$200,000. for administration.

The Board maintained total annual funding, inclusive of and from the year 2000 through 2005, at approximately \$190,000., not including legal aid contribution.

The \$500,000., highest level, for grants stabilization in the event of revenue reduction was reduced by \$6,591. in 2002 (4.19% acp, down from 6.01% acp in 2001 and 7.23% acp in 2000); \$91,752. in 2003 (4.69% acp); \$113,245. in 2004 (4.005% acp); and \$44,664. in 2005 (4.39% acp) (Balance: \$500,000., December 31, 2001; \$493,409., December 31, 2002; \$401,657., December 31, 2003; \$288,412. December 31, 2004; \$243,748., December 31, 2005).

The Board reduced a number of grants by approximately \$36,000. for 2006, which is 20% from their 2005 grants.

The grants approved for 2006 total \$157,204. and the change in the grants stabilization portion of the Reserve Account at December 31, 2006 will be dependent on 2006 revenues to the Foundation.

Pursuant to the Law Society Act, the Board must contribute two-thirds (increased by government from one-third effective January 1, 1992) of the net revenues received in each calendar year directly to the Legal Aid Commission. Net revenues are defined as all interest earned, less office, salaries, professional fees and other administrative expenses. The two-thirds contribution to the Legal Aid Commission was 265,806. for calendar year 2005 (4.39% acp), compared to 173,839. for calendar year 2004 (4.005% acp), 206,639. for 2003 (4.69% acp), 100,121. for 2002 (4.19% acp), 392,778. for 2001 (6.01% acp), and 504,581. for 2000 (7.23% acp).

The interest rate applied through 2000 averaged 3.23% (7.23% acp), using the then prime minus 4% (a negotiated 1% improvement from the historic rate of prime minus 5%), and yielded revenues of \$846,208. A further improved rate of prime minus 3% (a negotiated 2% improvement from the historic rate of 5%), which came into effect in 2002 and which will continue in 2006, and beyond, is referenced below.

Composite prime, for the month, in 2001 started at the high of 7.50% at January 1, and steadily declined to 6.25% at June 30 and 4.00% at December 31. The interest rate applied through 2001, using prime minus 4%, moved from 3.50% to 2.25% to what would have been 0.0% except for the banks applying the provisions of a previously negotiated minimum rate approximating 1.15%, or a tiered rate or interim rate of prime minus 3%, with or without service charges, depending on the financial institution.

In 2002 through 2005 these negotiated rates were applied. A number of banks during this period through continued negotiations have removed the interim status and the rate of prime minus 3% or the tiered rate, depending on the bank, will continue to be applied for periods beyond 2006.

Prime has increased to 5.75% at April 30, 2006, which provides an interest rate applied of 2.75% at prime minus 3%, versus 1.75% at prime minus 4%.

Composite prime, for the month, in 2005 started at 4.25% at January 1, and, from August 31, started to steadily increase to 4.75% at November 30, 2005, to 5.54% at March 31, and prime is 5.75% at April 30, 2006.

Further, the improved rate of prime minus 3% will continue to be applied to a revenue base, being the total amount of monies on deposit in all lawyers'

mixed trust accounts across the province, that has increased significantly over these past twenty-five years. The total amount of the provincial revenue base can be estimated from the revenues received by the Law Foundation, which are net of service charges where a bank applies them, and the applicable interest rates.

When the Law Foundation was established in February, 1980, interest was paid by financial institutions on the minimum monthly balance in lawyers' trust accounts. Effective in 1987, the interest became paid on the average monthly credit balance.

The interest paid on lawyers' mixed trust accounts by banks in the province is generally calculated on the monthly average prime minus an agreed upon percentage, historically 5%, then 4%, and, for the past few years, 3% at a number of banks, on the average monthly credit balance. Several banks alternatively have used a tired interest structure with competitive short-term deposit rates or prime minus various percentages, depending on account balances. A number of the banks, as well, waive basic service charges. The rates may differ between the banks and within the same bank nationally.

The interest earned on lawyers' mixed trust accounts is calculated by financial institutions based on interest rates and terms negotiated by the Foundation with the individual financial institutions. The interest is recorded by the Foundation upon receipt of the funds.

The lawyers' mixed trust accounts are not the property of, nor administered by, the Foundation. The Foundation is, therefore, unable to determine the amount of interest earned until such time as it is received from each individual financial institution, upon the lawyers' filed instructions.

The Foundation assumes that lawyers who receive or hold funds in trust for, or on account of, clients comply strictly with section 69 of the Law Society Act and the Trust Account Rules of the Law Society. This compliance requires that lawyers credited with interest earned on funds held in lawyers' mixed trust accounts shall remit it to the Foundation.

The Law Foundation of Newfoundland and Labrador in 1984 established funding for annual Law School Entrance Scholarships, in honour of the incorporation of the Law Society in 1834. The Scholarships, valued at \$5,000. each, are tenable for first year studies at any Canadian Law School.

The Scholarships are awarded to residents of the Province of Newfoundland and Labrador on the basis of academic excellence.

University of Toronto, and Danielle R. Rumbolt of Stephenville, studying at Dalhousie University.

The Board of Governors of the Law Foundation is advised when the awards have been made.

The Law School Scholarships Trust Fund is separate from and in addition to the above stated equity position of the Foundation.

The Law Foundation of Newfoundland and Labrador annually offers up to five Legal Research Awards valued at \$500. each to undergraduate students for best research term paper on one or more legal issues, or topics treated in a legal context, in a senior level course in any discipline at the undergraduate level. The papers submitted by and with endorsement of course professor or lecturer are judged initially by the Dean, or Director, or Department Head who makes a recommendation to a Selection Committee for the Awards. The Selection Committee comprises appointees of Memorial University and the Law Foundation. The Awards are made by the Senate Committee on Undergraduate Scholarships and Financial Aid acting upon the recommendation of the Selection Committee. An additional \$500. is provided annually by the Law Foundation to Queen Elizabeth II Library for the purchase of research materials and resources. Total Awards \$3,000. CENTENNIAL LAW SCHOOL SCHOLARSHIPS

In honour of the 100th Anniversary of the Faculty of Law, University of New Brunswick in 1992, the Law Foundation of Newfoundland and Labrador provided a \$50,000. grant to the Heritage Campaign establishing a Scholarships Fund to award two scholarships, valued at \$1,750. each, for students enrolled in the Faculty of Law who are residents of the Province of Newfoundland and Labrador.

One scholarship is awarded to an upper year student based on a combination of financial need and demonstrated academic ability in the LLB program.

William Sheppard of Mount Pearl, a second year law student, received the award in the second semester 2004/2005.

The other scholarship is awarded on the basis of academic excellence to a student entering first year.

Stephanie Hillier of Mount Pearl received the award in the first semester 2005/2006.

The scholarships are awarded annually by the Admissions and Scholarships Committee of the Faculty of Law. The Law Foundation of Newfoundland and Labrador is advised when the awards have been made.

In 1986 the Law Foundation of Newfoundland and Labrador provided a \$50,000. grant to Dalhousie University, as part of the Campaign for Dalhousie, following the August 16, 1985 fire, for the reestablishment of the Dalhousie law library.


Amy King commenced university studies in September, 2005, and was the winner of the
